

CONTRACTOR TO PROVIDE MATERIALS TESTING FOR ASPHALT AND CONCRETE IN ACCORDANCE WITH THE REFERENCED SPECIFICATIONS. FREQUENCY OF ALL TESTS SHALL BE PER THE APPLICABLE SPECIFICATIONS OR GEOTECHNICAL REPORT, WHICHEVER IS MORE STRINGENT
- THE COSTS OF ALL TESTS WILL BE PAID BY THE CONTRACTOR. CONTRACTOR TO PROVIDE AN AS-BUILT SURVEY SHOWING LOCATIONS AND ELEVATIONS OF ALL CONSTRUCTED
- FEATURES. SIGNED BY A PROFESSIONAL SURVEYOR AND MAPPER LICENSED IN THE STATE OF FLORIDA. 10. UNLESS NOTED OTHERWISE ON THE PLANS, ANY AREA DISTURBED DURING CONSTRUCTION WITHIN PUBLIC RIGHT-OF-WAY OR ON PRIVATE PROPERTY SHALL BE RESTORED TO EQUAL OR BETTER CONDITION. THIS INCLUDES ALL GRASSING, HEDGES, BUSHES, TREES, LANDSCAPING OF ANY KIND, PAVEMENT, SIDEWALKS, SLABS, STRUCTURES, WALLS, FENCES, SIGNS, POSTS, POLES OF ANY KIND, GUARD RAILS, ETC. CONTRACTOR TO PROVIDE A VIDEO TAPE DOCUMENTING EXISTING CONDITIONS TO THE ENGINEER PRIOR TO COMMENCEMENT OF WORK.
- 11. ALL DEBRIS. SPOIL. RUBBLE. VEGETATION. UNSUITABLE MATERIAL EXCAVATED FROM THE SITE AND SIMILAR ITEMS SHALL BE REMOVED AND BE LEGALLY DISPOSED BY CONTRACTOR.
- 12. THE CONTRACTOR SHALL BE RESPONSIBLE FOR REVIEWING ALL DRAWINGS AND SPECIFICATIONS FOR ACCURACY AND COMPLETENESS AND FOR PROPER COORDINATION OF ALL DISCIPLINES AND TRADES. NOTIFY THE ENGINEER IN WRITING IMMEDIATELY IF ANY DISCREPANCIES ARE FOUND IN THE PLANS OR SPECIFICATIONS. NOTIFY THE ENGINEER AND OWNER IN WRITING IMMEDIATELY OF ANY DISCREPANCIES FOUND BETWEEN THE CONTRACT DOCUMENTS AND EXISTING SITE CONDITIONS, WHETHER ABOVE-GRADE OR BELOW GROUND. ANY WORK DONE AFTER DISCOVERY OF A DISCREPANCY, UNTIL NECESSARY REVISIONS TO THE CONTRACT DOCUMENTS ARE AUTHORIZED, SHALL BE AT THE CONTRACTOR'S OWN RISK.
- 13. CONTRACTOR SHALL BE SOLELY RESPONSIBLE FOR INITIATING, MAINTAINING AND SUPERVISING ALL SAFETY PRECAUTIONS IN CONNECTION WITH THE WORK. CONTRACTOR SHALL TAKE ALL NECESSARY PRECAUTIONS AND COMPLY WITH ALL APPLICABLE LAWS AND REGULATIONS RELATED TO SAFETY OF PERSONS AND PROPERTY. PROTECT THE PUBLIC AT ALL TIMES WITH FENCING, BARRICADES, ENCLOSURES, ETC.
- 14. PRIOR TO SUBMITTING A BID, CONTRACTOR SHALL VISIT THE SITE TO BECOME FAMILIAR WITH THE LOCAL CONDITIONS THAT MAY IN ANY MANNER AFFECT COST, PROGRESS OR PERFORMANCE OF THE WORK. AFTER REVIEWING THE CONTRACT DOCUMENTS, CONTRACTOR SHALL NOTIFY THE OWNER'S REPRESENTATIVE OF ANY DISCREPANCIES. CONTRACTOR SHALL PERFORM ANY SUBSURFACE INVESTIGATIONS DEEMED NECESSARY FOR BIDDING AND PERFORMING THE WORK. ANY SUCH INVESTIGATIONS SHALL BE COORDINATED WITH THE OWNER'S REPRESENTATIVE
- 15. ALL WORK SHALL BE PERFORMED IN A WORKMANLIKE MANNER AND SHALL MEET ALL FEDERAL, STATE AND LOCAL
- REQUIREMENTS. ALL MATERIALS SHALL BE NEW UNLESS INDICATED AS EXISTING TO BE RELOCATED. 16. THE CONTRACTOR IS RESPONSIBLE FOR COORDINATING ALL INSPECTIONS, TESTS AND FIELD REVIEWS AND SHALL PROVIDE 48 HOURS NOTICE TO THE ENGINEER. THE CONTRACTOR SHALL SUPPLY ALL EQUIPMENT, LABOR AND MATERIALS NECESSARY TO PERFORM THE INSPECTIONS, TESTS AND FIELD REVIEWS. CONTRACTOR TO KEEP ALL WORK OPEN THAT IS SUBJECT TO REVIEW UNTIL SUCH REVIEWS BY CITY, UTILITY COMPANIES, OWNER, ETC. ARE PERFORMED.
- 17. THE CONTRACTOR SHALL PREPARE A MAINTENANCE OF TRAFFIC PLAN, PREPARED BY AN INDIVIDUAL CERTIFIED IN ADVANCED MAINTENANCE OF TRAFFIC. THE CONTRACTOR SHALL OBTAIN A MAINTENANCE OF TRAFFIC PERMIT AS REQUIRED FROM THE FLORIDA DEPARTMENT OF TRANSPORTATION.

CONTRACTOR TO PROVIDE ALL WORK IN ACCORDANCE THE FLORIDA DEPARTMENT OF TRANSPORTATION (FDOT) STANDARD PLANS AND STANDARD SPECIFICATIONS FOR ROAD AND BRIDGE CONSTRUCTION, LATEST EDITION, UNLESS NOTED OTHERWISE IN THE SPECIFICATIONS CONTAINED IN THE CONTRACT DOCUMENTS. THE CONTRACTOR AND SUBCONTRACTOR SHALL OBTAIN A COPY OF THE ABOVE-REFERENCED DOCUMENTS AND BECOME FAMILIAR WITH THEIR CONTENTS PRIOR TO COMMENCEMENT OF CONSTRUCTION.
